1. What, in your opinion, have you and your Fellow/program/project gained from your cooperation thus far?

I have learned how to advice on a preparation of a research report in the situation when data is very scarce, incomplete or unavailable.
Mr. Amirjanyan made an immense progress in secondary data collection, improved his analytical and presentation skills and learned useful methodological approaches to analysing the demand for tobacco in Armenia.
We both learned together what kind of essential data are missing in Armenia and have now a better understanding of what kind of research would be the most beneficial and the most cost effective in the country.

## 2. Do certain areas of this Fellow's work need improvement? Which areas?

I would suggest a course in econometric estimating techniques, a course in advanced statistical methods, and a course in writing a research paper.
3. In your opinion, does your Fellow's project make a significant contribution to the field?

Yes, the type of information provided in Mr. A mirjanyan's paper will be very useful for local tobacco advocate groups when negotiation the content of the recently discussed tobacco control law in A rmenia. In my opinion the study has a good chance to be published in an international journal.
